CHAPTER I

Learning Communities are a kind of co-registration or block scheduling that enables students to take courses together, rather than apart (Tinto, 2003: 1). According to Bloom and Sommo (2005: 13), learning communities are any one of a variety of curricular structures that link together several existing courses or actually restructure the material entirely so that students have opportunities for deeper understanding and integration of the material they are learning, and more interaction with one another and their teachers as fellow participants in the

learning enterprise. Groups and communities are having characterized both working and learning in terms of communities, it is worth pausing to establish relations between our own account and recent work on group in the workplace (Brown and Duguid, 1991: 48).

2. Learning English

Learning is the process of changing behaviour in the context of experiences that have been designed for the most part (Hayati, 2017: 2). Learning is conceived of as something a learner does, not something that is done to a learner (Pederson and Digby, 2013: 9). From both of statement above the writer concludes that learning is the activity in finding knowledge through changing behaviour and the role of learner in share the idea each other. Learning is a personal but social process that results when individuals cooperate to construct shared understandings and knowledge (Pederson and Digby, 2013: 9).
